

CA PALAPALA ALAKA `I NO NĀ HAWAI `I ME NĀ LĀHUI O KA PĀKĪPIKA

PEHEA E KOHO PĀLOKA AI

Ke noho nei kākou ma kēia wā ma'i ahulau e pā nei ke ao holo'oko'a, ka ma'i i pā'ino ai nā kaiaulu Hawai'i a me nā Lāhui o ka Pākīpika. Ua lawehala ka ma'i kolona i nā pono kaulike 'ole ma nā 'oihana, nā lawelawe olakino, nā hale a me ka ho'ona'auao 'ana; mai ka palekana 'ole o nā honua hana a i ka nele i ka loa'a o ka hana lawelawe olakino a i ka ho'omaka'u no ke kipaku 'ia 'ana mai ka hale. Ma kēia wā koho pāloka, he ko'iko'i nō ko kākou nohona a pono siwila no ko mua aku. He 'i'ini nui ko kākou i ka mea ho'okahi nō 'o ia ho'i, he wahi noho palekana a me ka 'ohana ikaika a pa'a o ke kino, ka ho'ona'auao keu a ka maika'i no kā kākou mau keiki a me kā kākou mau mo'opuna, a me ka hiki iā kākou ke mālama i nā kānaka i aloha nui 'ia. Ke pilikia nei nā Hawai'i, nā Lāhui o ka Pākīpika, a me nā Pā'ele, nā Paniolo, nā kānaka 'oiwi, nā Asia a me nā kaiaulu nona nā kānaka lawehana ma loko o ka loa'a 'ana o ke \$76 biliona i nā kānaka ma loko o nā mahina 'elua ma ka ho'omaka 'ana o ka ma'i ahulau i nā kānaka waiwai loa 5 o 'Amelika Hui Pū 'Ia. I mea e puka ai kākou mai kēia wā pōpilikia a kūkulu hou 'ana i moku'āina ikaika, he mea nui ko kākou koho pāloka 'ana no ko mua aku. Ke alulike kākou, he mana ko kākou.

- 1 E KĀINOA.** E kāinoa no ke koho pāloka 'ana ma ka pūnaewele ma mua o ka 19 'Okakopa. Hiki ke kāinoa ma ka lā ho'okahi nō o ke koho pāloka 'ana ma Kaleponi, akā pono 'oe e helekino.
- 2 E KOHO PĀLOKA MA KA LEKA 'ANA.** Ma Kaleponi, e ho'ouna 'akomi 'ia aku ana ka palapala e koho pāloka ana ma ka leka i nā kānaka i kāinoa 'ē. E ho'ouna 'ia ana ia mau palapala pāloka ma ka 3 'Okakopa. No ka hō'oiia i ka ho'ouna 'ia 'ana o kāu pāloka, e ho'ohana i ka polokalamu ho'okolo pāloka ma ka leka a e hō'oiia paha ma ke ke'ena koho pāloka o kou kalana. E ho'iho'i ho'i i ka pāloka i ka pahu no ke koho pāloka 'ana a i 'ole paha ma ka leka. Pono e pāniki leka 'ia ma mua a ma ka 8:00 pm ma ka 3 Nowemapa.

- 3 E KOHO PĀLOKA MA KA HELEKINO 'ANA.** Inā e koho pāloka ana ma ka helekino 'ana, e koho koke i 'ole lō'ihī ka laina kūkali. 'O ka 24 'Okakopa ka ho'omaka 'ana o ka wā koho pāloka, a 'o ka 3 Nowemapa ka lā hope. No ka 'ike 'ana i kahi āu e koho pāloka ai a me kahi e koho pāloka koke ai, e kele ma sos.ca.gov/elections/polling-place.

Stem Cell Research

E hā'awi 'ia nā pona he \$5.5 biliona ka huinanui no ko ka moku'āina nō'i 'ana i ka stem cell.

YES ON PROP 15

Schools and Communities First



He 39 ke kūlana o Kaleponi ma 'Amelika no ka ho'olilo haumāna pākahi a nona nā papa nui loa o nā moku'āina a pau. Ma ka Prop 12 he loa'a he \$12 biliona hou no nā kula aupuni me nā polokalamu kōkua (e like me ka papahana ho'olako wahi noho, nā wahi olakino, nā kānaka kinai ahi a me nā alakau aupuni) ma ka pani 'ia 'ana o nā ala ho'ālo 'auhau no nā 'oihana waiwai loa me ka mālama pū 'ana i ka po'e 'ona hale, ka po'e ho'olimalima hale, a me nā 'oihana li'ili'i. E ulu ana he 92% o ka loa'a na nā 'oihana waiwai loa he 10% e ho'ololo 'ia ana ma ko kākou mau kaiaulu. 'O kēia ka wā 'o ko ia mau 'oihana waiwai loa e uku pū e like me kākou.

'O Kaleponi, 'o ia ho'okahi o 9 moku'āina e pāpā ana i nā papahana pono kaulike. He mea nui ka pono kaulike no ka po'e e ho'okae 'ia nei ma muli o ka lāhui, ke keka, a me ke kūlana 'oiwi. 'O nā wāhine pākīpika ka po'e nona nā koā nui loa o ka uku ma 'Amelika. He ho'iho'i ka Prop 16 i ka pono ho'okae 'ole no ka lāhui, ke keka, ka 'oiwi, ka 'āina hānau no ka hai 'ia ma nā hana aupuni, ka ho'ona'auao a me ka hana 'aelike kekahi. Free the Vote

Ma kahi o ke 50,000 kĀnaka no Kaleponi i ho'oku'u palola 'ia a e hana nei ma ko kĀkou mau kaiaulu ma ke 'ano he limahana ko'iko'i i kĕia wā o ka ma'i ahulau. He ho'iho'i 'ia ka mana koho pĀloko i nā kĀnaka i ho'opa'ahao 'ia no nā peloni ma ka palola, i hiki iā lākou ke komo hou i ka hana o ke aupuni na ka lehulehu ma hope o ka ho'oku'u 'ia 'ana mai ka hale pa'ahao.

17 Year Old Voting Rights

Ma nā mo'olelo o ka wā ma mua, 'o ka 'ōpio ka po'e e 'imi ana i ka pono no ko kĀkou mau kaiaulu- e hāpai ana i nā kĀnawai no ke kaiāulu, ka hele 'ana i kĕlā me kĕia hale no ke kama'ilio 'ana me nā kĀnaka koho pĀloka a me ke kōkua 'ana i nā 'ohana o nā kĀnaka ko'iko'i lawehana. He 'āpono ka Prop 18 i nā kĀnaka 17 makahiki a e piha ana he 18 makahiki i ka wā o nā koho wae moho me nā koho wae hou a'e, a he ho'onui a'e kĕia i ka po'e komo i ka hana o ke aupuni na ka lehulehu.

He ho'ololi ho'i i nā kĀnawai no ka ho'opane'e 'ia 'ana o ka 'auhau honua a me ka 'auhau ho'oilina.

NO ON PROP 20

Criminal Sentencing, Parole, and DNA Collection

No ka wā lō'ihi, ua kaulike 'ole a 'o'ole'a nā kulekele ho'opa'i ho'opa'ahao i pā 'ino i nā kaiaulu nele a po'e 'u'uku. Ho'onui ho'i ka Prop 20 i kĕia pilikia ma ka ho'emi 'ia 'ana o nā papahana palola no nā kĀnaka kalaima pepehi 'ole, a e ho'onui i nā hewa e helu papa 'ia e kĀohi ana i ka pĀlola 'ia 'ana o nā kĀnaka ho'opa'ahao 'ia. He wae'anona hou 'ia nā kalaima ma ke 'ano he kalaima li'ilii' a i peloni, a e koi 'ia ana ka 'ohi 'ana i ka DNA o nā kĀnaka i ho'āhewa 'ia no nā kalaima li'ilii. Ma ka puka ana o ka Prop 20 e ho'onui 'ia ana nā kalaima o ko kĀkou mau kaiaulu a e ho'oka'awale 'ia ana nā 'ohana ma kahi o ka ho'oponopono a me ka ho'iho'i.

YES ON PROP 21

Rent Control

Pipi'i loa ka uku ho'olimalima, Pa'akikī ka uku 'ana i nā ho'olimalima hale no ka hapanui o nā kĀnaka ma Kaleponi a ho'olilo 'ia ma 'ō aku o ke 30% o kĀ lākou uku ma ka ho'olimalima hale. He mau kekeke ka lō'ihi o ke kŪkulu 'ia 'ana o nā kaiaulu e nā limahana he komone'e a mea pakeke paha. Ke ho'okuke 'ia nei lākou mai ia mau kaiaulu a lākou i kŪkulu ai ma muli o ka pi'i 'ana o ke kumukū'ai ho'olimalima hale. Ho'ākea ka Prop 21 i ka mana o ka nā kalana e ho'opa'a i nā lula e kĀohi ana i ka ho'opi'i 'ia o ka ho'olimalima hale ma loko o ka 15 makahiki e hō'ioia pū ana i ka 'a'e 'ole ana i nā pono o nā kĀnaka no lākou ka hale ho'olimalima a i ka uku i kaulike no ko lākou hale.

NO ON PROP 22

Gig Workers Classification

Kāko'o 'ia ka pono kanaka o nā limahana. E ho'ololi ana ka Prop 22 i nā kŪlana no nā kĀnaka halihali no nā polokalamu pūnaeweale mai ke kŪlana limahana a i ho'a'aelike. Ma ka loli o kĕia kŪlana e hiki ana i nā 'oihana e like ho'i me Lyft, Uber a me Doordash ke hō'ole i nā pono limahana e koi 'ia no nā limahana. He pani ho'i kĕia loli i ke ala o ka uniona no ka ka mea 'ae 'ia kĕia hana no nā limahana wale nō ma lalo o ke kĀnawai pekkelala.

NEUTRAL ON PROP 23

Kidney Dialysis Regulation

Ma ka Prop 23, koi 'ia ka loa'a o kekahi kauka ma ka honua o nā wahi dialysis a me ka 'āpono mua 'ia 'ana o ka pani 'ia o ia wahi e ka moku'āina. Kāko'o 'ia kĕia Prop e nā Uniona o nā limahana ma ka 'oihana mālama olakino.

NEUTRAL ON PROP 24

Consumer Privacy

Ho'ākea ka Prop 24 i nā mea e 'ae 'ia ma ka California Consumer Privacy Act (CCPA). Kū'ē nā Hui 'Auhau 'Ole 'Imi pono kaulike e like ho'i me ka ACLU o Kaleponi i kĕia.

YES ON PROP 25

Referendum on Bail Reform

He ho'okae ka 'ōnaehana pĕla i ka po'e 'ilihune a me ka po'e 'u'uku ma ke koi 'ana i nā kĀnaka e kali ana i ka ho'okolokolo 'ia 'ana e uku i ka pona pĕla emi a i 'ole e kali lākou no kekahi mau pule a mahina paha ma ka hale pa'ahao. 'O ka po'e i hiki ke uku, 'o ia nō ka po'e ho'oku'u 'ia a 'o nā kĀnaka i hiki 'ole ke uku, noho ka'awale lākou mai nā ka 'ohana a ho'oku'u pū 'ia paha mai kĀ lākou hana, ma loko nō o ke kŪ i ka hewa 'ole. Ma ka prop 25, he pani 'ia ke pĕla me kekahi loiloi hō'a'ano na nā luna ho'okolokolo.
